RE: Contract Amendment: Legislative Representation for FY 2009-11: Government Relations, Inc. – Thomas J. Bulger

For compelling business reasons, staff recommends extending MTC's contract with Government Relations, Inc. to provide legislative representation services in Washington, D.C. on a sole source basis for an additional two years, through October 30, 2011. Mr. Bulger's contract was last extended for a period of two years in October, 2007.

Background

A new Congress and a new President will be taking office in January, 2009 and one of their first challenges will be to renew the federal transportation legislation that will expire on September 30, 2009. Having lasted almost 20 years since passage of ISTEA, the existing policies that have dominated the post interstate highway era may be revised significantly in 2009. The Commission is likely to play a significant role in redefining the federal transportation policy.

There is much uncertainty as to when a final bill will emerge. While work has already begun in earnest and a deadline of September 30, 2009 looms, final legislation may well take a year or more to negotiate.

Sole Source Justification

MTC's representative in Washington, Tom Bulger, has a contract with the Commission that is set to expire October 31, 2009. Going out with a competitive procurement for a legislative representative in the middle of a reauthorizing process would be very disruptive to our efforts in Washington D.C. as it falls in the middle of what could be a protracted and long fought effort.

Mr. Bulger has represented the Commission in Washington, D.C. since 1984 and has remained an important element in MTC's effort to improve federal transportation policy in light of the many challenges facing our nation's policy makers. He possesses extensive governmental and advocacy experience as well as close relationships with key members and allies on transportation-related committees in Congress, the Administration and federal agencies. Besides serving the Commission well during three federal transportation reauthorizations, Mr. Bulger has a unique understanding of the Bay Area and its many transportation players and has served the region well coordinating the dozens of Bay Area transit operators and other transportation interests who also have a presence in Washington, D.C.

Recommendation

Mr. Bulger's contract for this fiscal year totals \$216,400. As in past years, we recommend increasing that amount by 5% each year, to meet an expected level of inflation and a modest increase to reward work well done. The annual amounts would total \$227,200 and \$238,600 in FY 2010 and FY 2011, respectively, and an amount of \$87,680 for the four months of July through October 2011 that coincide with MTC fiscal year FY 2011-12, subject to our annual budget approval process.

Staff recommends that the Committees authorize the Executive Director or his designee to enter into a contract amendment with Tom Bulger (dba Government Relations, Inc.) in the amount of \$497,254. Funding for this contract amendment, as indicated in the attached Summary of Contract Approval, are subject to approval of future year agency budgets.
