AB 153 (Ma) Sustainable Communities Strategy Vehicle Registration Fee Safe, Clean Reliable Drinking Water Supply Act of 2012	Authorizes metropolitan planning organizations and councils of government, and in the Southern California Association of Governments (SCAG) region, a county transportation commission and subregional council of government, to place on the ballot within their jurisdiction a motor vehicle registration fee of up to \$4 until January 1, 2016 for the purpose of developing and implementing a Sustainable Community Strategy (SCS) as required by SB 375 (Steinberg, 2008). Provides that if the fee exceeds \$2, all revenue in excess of \$2 shall be made available to cities and counties for planning and projects related to implementation of the SCS. Authorizes the entity imposing the fee to share its revenue with the local air quality management district. Establishes the Planning Advisory and Assistance Council within the Governor's Office of Planning and Research. Amends the Safe, Clean, and Reliable Drinking Water Supply Act of 2012 to require that not less than a specified amount of bond funds under the act be available for costs associated with projects that reduce the contamination of groundwater that serves as a source of drinking water. Requires the Secretary of State to include these changes when submitting the bond act to the voters. (Amended 8/30/10)	Enrolled	
AB 289 (Galgiani) High-Speed Rail	Identifies the corridors eligible for ARRA funds. Authorizes the Governor to appoint civil service exempt staff for specified positions to oversee the work of the authority in implementing the project. <i>Removes urgency provision.</i> (Amended 8/27/10)	Enrolled	
AB 497 (Block) High-Occupancy Vehicle Lanes: Physicians	Permits a physician to travel in HOV lanes, when traveling in response to an emergency call, regardless of the number of occupants in the vehicle, if that physician displays the insigne approved by the Department of Motor Vehicles. Provides that the law shall only apply if the Director of Transportation determines that it will not subject the state to a loss in federal funds. (Amended 5/14/09)	Died	Oppose
AB 569 (Emmerson) Meal Period Requirements: Exemptions	Exempts construction employees, commercial transportation drivers and employees in the security services industry employed as security officers who are covered by a valid collective bargaining agreement containing meal period provisions from existing law with regard to meal period requirements. AB 619 (Blumenfield) High-Speed Rail Authority: Contract Reporting Requirements Related to WW II	Establishes procedures to be followed by entities that intend to bid or submit a proposal to contract with the High Speed Rail Authority. Requires any entity applying for a contract with the authority to affirmatively certify whether it had any direct involvement in the deportation of any individuals to extermination camps, work camps, concentration camps, prisoner of war camps, or any similar camps between specified dates during World War II. AB 726 (Nielsen) Transportation Capital Improvements	States that local road rehabilitation projects are eligible for transportation capital improvement funds pursuant to the State Transportation Improvement Program. (Introduced 2/26/09)	Died	
AB 732 (Jeffries) Transportation Projects: Design-Sequencing	Extends the operative date of existing law from January 1, 2010 to July 1, 2010 that authorizes the Department of Transportation to conduct phase 2 of a pilot project through the utilization of design sequencing contracts for the design and construction of transportation projects, taking into consideration specified geographical consideration. Reduces the number of projects authorized from 12 to nine. (Amended 6/16/09)	Died	
AB 744 (Torrice) Bay Area High-Occupancy Transportation Network	Authorizes the Bay Area Toll Authority to develop, administer, operate and maintain an express lane network on state highways within the geographic jurisdiction of the Metropolitan Transportation Commission. Authorizes capital expenditures for this program to be funded from program revenues, revenue bonds, and revenue derived from tolls on state owned toll bridges, except that toll revenues may only be used as loans. AB 909 (Hill) Right-turn Violations	Modifies the current \$100 penalty for a driver that does not stop at a red traffic light signal and yield to pedestrians prior to turning right (or left onto a one-way street) to a fine "not to exceed \$100." (Amended 8/3/10)	Enrolled	
AB 987 (Ma) Transit Village Development District	Amends the Transit Village Development Planning Act of 1994 to require that a transit village development district include all land within not less than ½ mile of the exterior boundary <i>main entrance</i> of a transit station, rather than ¼ mile. AB 1375 (Galgiani) High-Speed Rail	For purposes of managing and administering the ongoing work of the authority in implementing the high-speed train project, authorizes the Governor, upon the recommendation of the executive director, to appoint up to six additional authority employees, exempt from civil service, who would serve in specified positions at the pleasure of the executive director. Requires a salary survey to be conducted to determine the maximum compensation for the executive director and additional exempt employees, and would require the salaries to be approved by the Department of Personnel Administration. (Amended 6/22/10)	Died	
AB 1500 (Lieu) High Occupancy Vehicle Lane: Low-Emission Vehicles	Extends by five years the sunset date (from January 1, 2011 to January 1, 2015) for allowing certain low-emission vehicles access into high occupancy vehicle lanes regardless of the number of occupants. Provides that all such vehicles would be granted the same discount toll applicable to carpools on the region's seven state-owned toll bridges. (Amended 5/26/10)	Enacted, Chapter 37	Oppose
AB 1502 (Eng) Minor's Application for Driver's License	Authorizes a person who is licensed under any state and the parent or guardian of a minor who is a member of the Armed Forces of the United States on active duty, stationed in California, or his or her spouse, to accompany and supervise the holder of an instruction permit, to accompany a holder of a provisional license, and to sign and verify the minor's application for a license or instruction permit. Requires a lead agency, if a proposed residential, retail, or commercial development project would preclude or substantially and directly impede the present or potential future use of lands for mineral extraction in an area that has received a classification by the State Geologist as containing mineral deposits of statewide or regional significance, to determine whether those impacts may have a significant effect on the environment, including, but not limited to, any significant effect on air quality. Requires a lead agency to determine whether impacts from a proposed residential, retail, or commercial development project would preclude or substantially and directly impede the present or future use of lands for mineral extraction in an area classified as containing mineral deposits of statewide or regional significance, and whether that may have a significant effect on the environment, including, but not limited to, any significant effect on air quality. AB 1760 (Blumenfield) Design-Sequencing Contracts	Authorizes Caltrans to let no more than five an unlimited number of design-sequencing projects until January 1, 2014 2016. Requires the department to prepare a status report to the Legislature each year during which design-sequencing contracts are underway. Specifies that the department may use design-sequencing only for projects in which a time savings will be realized, construction costs will be reduced, or available state or federal funds will be captured by utilizing design-sequencing. (Amended 7/15/10)	Enrolled	
AB 1784 (Fong) Santa Clara VTA: Local Roadway Improvements	Authorizes the Santa Clara Valley Transportation Authority (VTA) to enter into an agreement with any city within its jurisdiction or with Santa Clara County to improve a street, road, highway, or expressway under the jurisdiction of the city or county, not including any highway under state jurisdiction unless authorized elsewhere in statute. (Enacted 7/9/10)	Enacted, Chapter 57

AB 1855 (Yamada) Disabled Placards: Free Registration Notification Requirement	Requires the Department of Motor Vehicles to advise in writing an applicant for a disabled person's or disabled veteran's placard that he or she may be eligible to apply for a special license plate (exclusively available to disabled veterans) that is exempt from the payment of the registration fee and vehicle license fee. (Amended 8/27/10)	Enacted, Chapter 196	
AB 1871 (Jones) Personal Vehicle Sharing: Insurance	Prohibits a private passenger motor vehicle from being classified for insurance purposes as a commercial, for-hire, or permissive use vehicle, or livery solely on the basis of it being used for personal vehicle sharing if the annual revenue generated by personal vehicle sharing does not exceed the annual expenses of owning and operating the vehicle provided that the personal vehicle sharing is conducted pursuant to a personal vehicle sharing program. Defines a personal vehicle sharing program as a legal entity qualified to do business in the state that facilitates personal vehicle sharing. <i>Makes various other requirements for insurance used by personal vehicle sharing programs.</i> (Amended 8/20/10)	Enrolled	
AB 1958 (Caballero) Cost Cutting: Expedite Bond Projects	States the intent of the Legislature to enact legislation to require each department in state government to make recommendations on reducing its costs by 5%, and to use those cost savings to fund preapproved infrastructure projects not funded by existing bond funding. (Introduced 2/17/10)	Died
