Authorizes the establishment of an infrastructure financing district without a local vote to finance the improvements contained in the master plan Provides an exemption from CEQA for development projects consistent with the environmental impact report approved for the master plan. Requires the master plan to include incentives for encouraging investment and coherent growth in the areas surrounding the high-speed rail system in each participating jurisdiction. Requires the participating jurisdictions to collaborate with the State Air Resources Board to develop incentives to encourage development while concurrently reducing greenhouse gas emissions, consistent with or pursuant to the California Global Warming Solutions Act of 2006.
