Consent Calendar

Upon the motion of Commissioner Dave Cortese and the second from Commissioner Amy Rein Worth the Committee unanimously approved the following four consent items:

Mr. Scott Shepard presented the FasTrak[®] Toll Tags Purchase Order requesting the Committee approve issuing a purchase order to Federal Signal Technologies in an amount not to exceed \$2,681,111 to furnish a total of 219,000 standard and retail toll tags and a purchase order to Transcore, L.P. in an amount not to exceed \$124,775 to furnish a total of 5,000 external toll tags for the FasTrak[®] Regional Customer Service Center project.

Commissioner Haggerty asked where Federal Signal Technologies and Transcore, L.P. are located. Mr. Shepard replied they are located in Irvine, California.

Upon the motion of Commissioner Dave Cortese and the second of Commissioner Amy Rein Worth the motion passed unanimously.

BATA Resolution No. 98, Revised – BATA Operating Budget FY 2011-12

Steve Heminger explained to the Committee the new reorganization which would impact BATA by one new position.

Eva Sun, BATA staff went on to explain that the Committee would approve forwarding to the Authority BATA Resolution No. 98 which would amend the BATA
