### Attendance

### Update on MTC Response to Possible BART Strike

Ms. Melanie Crotty, MTC Operations staff updated the Committee about MTC's response to the possible BART strike. She reminded the Committee that as BART Management and the Unions continue to negotiate, MTC is updating its contingency plan to provide commuters with transit alternatives.

### BATA Resolution No. 109 - Air District Financing Plan

Mr. Brian Mayhew, Chief Financial Officer, requested the Committee forward to the Authority for approval BATA Resolution No. 109 which authorizes a contribution of funds to the Bay Area Headquarters Authority in the amount of \$30 million, to assist the Bay Area Air Quality Management District (Air District) in completing the purchase of their office space at 375 Beale Street. He advised that the payment structure will involve repayment to BATA by the Air District at a variable rate and a down payment amount of \$8 million.

Commissioner Haggerty asked why the Air District was only making a down payment of \$8 million. Mr. Mayhew responded that they made a commitment of a minimum \$8 million with the option to prepay the debt at any time and/or make a larger contribution.

Commissioner Quan asked for the total building and renovation cost. Mr. Steve Heminger, BATA Executive Director, responded that the cost was approximately \$200 million.

Commissioner Haggerty asked for the price of the building. Mr. Heminger responded that the building purchase price was \$93 million and it was reappraised approximately one year ago at \$130 million.

The Committee received public comment from Rich Hedges, who asked if the cost per square foot included tenant improvements and furniture. Mr. Mayhew answered in the affirmative.

Upon the motion of Commissioner Bates and the second of Commissioner Glover, the Committee unanimously approved forwarding to the Authority for approval BATA Resolution No. 109.
