RE: TIP Update

TIP Amendment 07-10

Amendment 07-10 is a major amendment that updates the project listing and funding for 31 projects throughout the region with a net funding change of \$94 million. The significant changes are as follow:

1. Modifies \$54.4 million for five projects within three of the Caltrans State Highway and Operations Program (SHOPP) Lump Sum listings;
2. Adds \$18.2 million for seven projects in the Transportation for Livable Communities (TLC) Program and one Port of Oakland Project;
3. Adds \$9.7 million for eight projects in the Regional Bicycle and Pedestrian Program;
4. Adds \$7.1 million to the Santa Clara Valley Transportation Authority's (VTA's) Zero Emission Bus (ZEB) Demonstration Project;
5. Adds \$2.7 million for seven new projects that are part of the Clean Air in Motion fund swap with the Bay Area Air Quality Management District; and
6. Adds the preliminary engineering phase for a Moveable Median Barrier Project on the Golden Gate Bridge for \$2.0 million in local funds.

TIP Amendment 07-10 was approved by the MTC Commission on June 27, 2007 and by Caltrans on July 27, 2007.

Administrative Modification 07-11

Amendment 07-11 is an administrative modification that updates the project listing and funding for 41 projects throughout the region. The amendment completes the Marin County Non-motorized Pilot Program lump sum split for better program management; proposes several fund source changes, and updates several CMIA and STIP Augmentation projects per final CTC action. Approval of TIP Amendment 07-11 is pending.

TIP Amendment 07-12

Amendment 07-12 is a single project amendment that adds \$24,999,999 in new Penta-5 funding to the Oakland Airport Connector project. The amendment was approved by the Commission on July 25, 2007, contingent on the close of public comment period on August 15, 2007. It will then be forwarded to Caltrans and FHWA/FTA for final approval.

Future Amendments

The next deadline to submit requests for a formal TIP amendment is November 1, 2007.
