RE: TIP Update

Administrative Modification 07-13

Amendment 07-13 is an administrative modification that made several minor revisions to project descriptions, project funding and project delivery schedules for 21 projects throughout the region. Caltrans final approval of the modification was received on September 5, 2007.

TIP Amendment 07-14

Amendment 07-14 updates the project listing and funding for 62 projects with a net funding change of over \$255 million. The significant changes in the amendment are as follow:

- Amends in \$40.2 million to the Fifth Street Bridge retrofit project in Oakland;
- Adds \$336 million to three Caltrans Management lump sum project listings;
- Removes \$170 million in local funds programmed in error to the Valley Transportation Authority Rail Replacement Programming; and
- Makes other major revisions to projects throughout the region.

TIP Amendment 07-16

Amendment 07-16 amends into the 2007 TIP over \$134M in Urban Partnership Pilot Program funds plus local match into seven (7) regionally significant projects. Public comment on the amendment will begin on September 17, 2007. MTC commission approval is expected on October 24, 2007.

The next deadline to submit requests for a formal TIP amendment is November 1, 2007.
